1. HOW TO ENTER

- a. These rules govern the KOSI 101.1 Dot Your Contest (the "Contest") being conducted by KOSI 101.1 (the "Station"). The Contest will begin on Monday, January 6, 2020 at approximately 8:00 a.m. MT Mountain Time ("MT") and will end on Friday, January 31, 2020 at approximately 4:00 p.m. MT ("Contest Period").
- b. To enter the Promotion:
  - i. On-Air: Listen to the Station weekdays January 6, 2020 through January 31, 2020 at 8:00 a.m., 1:00 p.m. and 4:00 p.m. MT. Each weekday of the contest, the Station will announce the cue to call "Alexa, play KOSI 101.1" at approximately 8:00 a.m. MT, 1:00 p.m. MT and 4:00 p.m. MT. The 10th caller to get through to the Station contest line at 303.290.1011 will win a qualifying prize of an Amazon Echo Dot, and be qualified to win the specified Grand Prize Las Vegas getaway for the weeks noted in Section 4b upon confirmation of eligibility ("On-Air Qualifier"). At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected, or is found to be ineligible, the next eligible caller that successfully completes the eligibility requirements will be determined the winner of the qualifying prize and become an On-Air Qualifier.

There is no purchase necessary to enter or win.

- a. Decisions of the Station management with respect to the Promotion are final.
- b. The station will award sixty (60) qualifying prizes, Amazon Echo Dots, from contestants that call in during the contest period. One (1) qualifier from each of the weeks noted in Section 4b will be drawn at random from on-air qualifiers in the 4:00 p.m. MT hour (January 10, 17, 24 and 31, 2020) as the Grand Prize winner for that week's Grand Prize getaway listed in Section 4b.
- c. On Monday mornings (January 13, 20, 27, 2020 and February 3, 2020) following the week of qualifying at approximately 7:00 a.m., Grand Prize winners will be announced on KOSI 101.1. Failure to comply with the rules of the Promotion may result in an entrant’s disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.
