- c. All listeners that have joined Jenny's Moms Club prior to October 5, 2020 are already entered.
- d. A listener may join Jenny's Moms Club only once to be a qualifier during the Contest period.
- e. Winner must have internet access to claim the prize. Winner will be required to sign an affidavit of eligibility. The winner will also be required to provide their complete address, date of birth and phone number to claim a prize.

 - i. All listeners that join Jenny's Moms Club between Monday, October 5, 2020, at approximately 6:00 AM MT and Sunday, October 25, 2020, at approximately 11:59 PM MT; and those listeners that have joined Jenny's Moms Club prior to October 5, 2020 will be qualified for a chance to win a \$150 gift card to Seasons 52 Fresh Grill & Wine Bar at 8325 Park Meadows Center Drive, Lone Tree, CO. Grand Prize Value: \$150.00.
- b. Must be 18 years of age or older. Not redeemable for cash, not transferable, may not be combined with another offer.
- c. Winners will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize.
- d. No more than the advertised number of prizes shall be awarded. The prize is subject to certain terms and conditions as specified herein. Prize may not be sold, traded, or commissioned, and is not exchangeable, transferable, substitutable, or redeemable for cash except in Company's sole discretion. The prize is expressly limited to the item(s) listed above and, unless otherwise expressly specified, does not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. The station will award one (1) Grand Prize from listeners that join Jenny's Moms Club during and prior to the Entry Period.
- c. The Grand Prize winner will be randomly drawn by the Promotions Department no later than 9:00 AM MT on Monday, October 26, 2020. Grand Prize Winner will be contacted on Monday, October 26, 2020, to work out award arrangements with the Station.
- d. Grand Prize Winner must execute and return any required affidavit of eligibility, W-9, and/or liability/publicity release online to claim the prize or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility, W-9, and/or liability/publicity release online within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize. Unless otherwise permitted by the Station, winner(s) must claim his or her prize by completing all claim forms and releases online. Grand Prize Winner cannot claim the prize in person at the station, and a prize cannot be claimed by third parties on behalf of the winner. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station

makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.

- b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Administrator or Sponsor, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Promotion webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- c. Calling the Station to participate in the Promotion constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Promotion may be taped without further permission from the caller. By entering the Promotion, all participants consent to the use of their name, photograph, likeness, biography, voice and/or video for advertising and promotional purposes, including online announcements, without limitation and without compensation.
